### **Specific Bequest Language:**

## Residual Bequest Language\*:

"I give, devise and bequeath to the Jansen Art Center, a nonprofit 501(c)(3) organization, tax id #: 45-4060718, [all or a percentage] of the residue of my estate." \*Residue is defined as that which remains after debts and expenses of administration, legacies and all other devises have been satisfied.

### **Contingent Bequest Language:**
